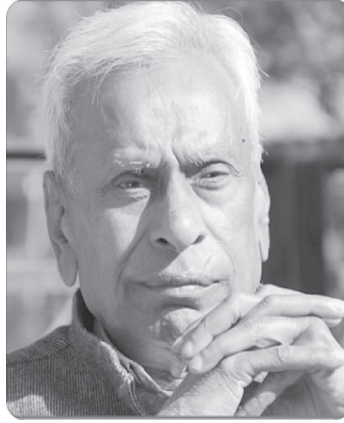
Editorial

TIE-UP ARRANGEMENTS WITH DIAGNOSTIC
CENTRES / ADDITION OF NEW DIAGNOSTIC
TESTS**

We invite a reference to our Circular letter no. HR:IR:SPL:52 & HR:IR:SPL:85 dated 12/05/2008 & 26/07/2012 respectively, wherein the guidelines related to tie-up arrangements with Diagnostic Centres have been laid down.

2. The tie-up arrangement with Diagnostic Centres has since been reviewed by the Central Office Human Resources Committee in its meeting held on 19/03/2019 and it has been decided to add the following diagnostic tests to the existing list of tests covered under tie-up arrangements with the Diagnostic Centres:

- Pap Smear
- Prostate Specific Antigen
- Dengue Test
- Serum Electrolyte Test

3. All other terms and conditions / guidelines related to tie-up arrangement with the Diagnostic Centres will remain the same.

4. The Chief General Manager (HR) at Corporate Centre will be the competent authority to issue any clarification in regard to the above arrangement.

5. The above changes will be effective from 01/04/2019.
