Another Setback : Our Court case W.P. 1875/2013 regarding 50% pension

The above mentioned case's hearing/arguments were slated for 11.07.2019 in which we were quite hopeful to listen some good news over the matter. But surprisingly and unfortunately that without hearing even a single word by the Judges, the case was postponed to 27.11.2019 for next hearing. There was a lot of resentment among all the pensioners and the office-bearers of the Circle Association & the SBI Pensioners Federation also. However, our Federation filed affidavit in the high court on 19.07.2019 for preponement of the above case & for special bench to be constituted for the same. This request was taken up by the Delhi High Court was discussed and our request was once again turned down by the Court on 23.11.2019.

2. Dear Comrades, the SBI Pensioners Federation is very much concerned about this development viz next date of 27.11.2019 and the General Body Meeting of the Federation has been called at Jaipur on 10th & 11th August, 2019 to discuss the next course of action by us for the early solution of the above case which has already consumed more than 6½ years. The

next development would be shared with our Circle Association members as and when we hear from the Federation.

3. It has come to our notice that one Mr. Umesh Sharma, who is petitioner in the above case as Individual, is contacting our members and misguiding through emotional writings for donation to continue to fight the case. Some members from Kullu, Mandi and Hoshiarpur have collected funds from the members in thousands of rupees and remitted to A/c No. 35204380854 maintained at SBI, Jagriti Vihar, Merrut. Comrades, we have nothing to do with this person and due to him, our above case is lingering on as all the arguments of our case
